TERMS AND CONDITIONS

A first installment payment of \$500 is required at the time of booking in order to reserve **C.Y. WEDDING FILMS** services for the wedding date. A second payment covering the remainder of the balance will be due anytime up until 1 Week prior to the wedding date. **C.Y. WEDDING FILMS** will not travel too location until this payment is received. If the client cancels the production prior to the wedding date, the initial deposit will not be refunded. Exceptions will be made if canceled within a reasonable amount of time, up to one week from this contract signing.

C.Y. WEDDING FILMS will perform production tasks to the best of their abilities, but accepts no responsibility for unforeseen circumstances including but not limited to equipment failure, power outages, illnesses, extreme weather conditions, inability to attend, and/or any other situation where the resulting video product is less than ideal. It is understood that the quality of the production is dependent upon adequate lighting, camera/microphone positions and other conditions not under the control of **C.Y. WEDDING FILMS**.

C.Y. WEDDING FILMS will take paramount concern to produce a finished product of excellent quality. By signing, you, the client(s), acknowledge that the finished product is a creative work, and as such, reasonable artistic license/discretion will be used in the filming and editing of the resulting video. Client requested changes to the finished product will be billed at \$150 per hour. **C.Y. WEDDING FILMS** stands by their style in producing wedding films, and it is the client's responsibility to ask questions, and make it vocal what their priorities are and what they would like captured.

C.Y. WEDDING FILMS will be the exclusive professional videographer. Friends and family are permitted to operate video cameras on the condition that they do not interfere with or get in the way of the professional coverage.

Any liability on the part of **C.Y. WEDDING FILMS** will be limited to the amount of monies paid.

C.Y. WEDDING FILMS will establish an arrival time for the event date with the client prior to that date and remain on duty as long as necessary to complete the requirements of the selected package. Exact coverage hours are determined at the discretion of the **C.Y. WEDDING FILMS** staff working the event.

C.Y. WEDDING FILMS reserves the right to discontinue videotaping in any situation (ex: rain, extreme temperatures, humidity, hazardous locations) that could put the safety of the videographer or equipment at risk.

For packages including reception coverage, the client agrees to provide **C.Y. WEDDING FILMS** with a meal during the time that the bride and groom are served at the reception. If this meal is provided out of view of the reception activities, **C.Y. WEDDING FILMS** cannot guarantee that any events occurring during the videographer's absence will be captured.

The original footage remains the property of **C.Y. WEDDING FILMS**. The client gives **C.Y. WEDDING FILMS** permission to use this footage to market **C.Y. WEDDING FILMS** wedding videography services. The client is responsible for all copyrighted music used in the wedding video.

Delivery of product will be approximately 6-8 weeks after the event. Due to the nature of the creative process the completion period is only an approximate length of time and any longer periods necessary for completion will not void this contract. The Videographer cannot accept responsibility for material lost or damaged in transit.

Any special requests overriding the terms and conditions of this contract must be specified prior to wedding date or at the time of this signing.
